## **ANNOUNCEMENT**

### **Resolutions of the Annual General Meeting of 12.7.2023**

Phoenix Vega Mezz Plc (the Company) announces the following:

At the Annual General Meeting of the Company, held on 12.7.2023 at 11.00 a.m., remotely, in real time via teleconference, shareholders representing 672.197.121 shares of the Company participated, specifically, with regards to matters of the agenda numbered 1 - 5, and as specifically stated in the notice dated 20.6.2023; the shareholders that participated in relation to the said matters of the agenda represent 53.76% of the issued share capital with voting rights.

Regarding the matters of the agenda, the Annual General Meeting:

1. Approved the Annual Financial Statements for year ending 31.12.2022, as well as the relevant Management and Auditors' Reports.

The voting results on the said matter were the following:

- Number of shares for valid votes given: 672.197.121 (100% of the share capital, i.e. shareholders present with voting rights for the said matter of the agenda), out of which:
  - For: 669.505.692
  - Against: 217.506
- Abstain: 2.473.923

2. Approved the remuneration of the Board of Directors for year 2023.

The voting results on the said matter were the following:

- Number of shares for valid votes given: 672.197.121 (100% of the share capital, i.e. shareholders present with voting rights for the said matter of the agenda) of which:
  - For: 669.723.192
  - Against: 6
- Abstain: 2.473.923

3. Approved the re-election of the Company's auditors Messrs. Baker Tilly.

The voting results on the said matter were the following:

- Number of shares for valid votes given: 672.197.121 (100% of the share capital, i.e. shareholders present with voting rights for the said matter of the agenda) of which:
  - For: 668.111.192
  - Against: 1.612.006
- Abstain: 2.473.923

4. Approved the remuneration of the Company's auditors.

Approved the reduction of the Company's share capital by Euro 18.005.288,0976 (eighteen million five thousand two hundred and eighty-eight Euros and 0976/1000 Cents), with a reduction of the nominal value of all its shares from Euro 0.0356 to Euro 0,0212 per share and authorized the Company's Board of Directors to implement the decision, of which:
